Dr. Howard Yeon is a board-certified orthopedic spine surgeon specializing in open and minimally invasive procedures of the cervical, thoracic and lumbar spine. A graduate of Harvard College, Dr. Yeon received his A.B. in Biochemical Sciences *magna cum laude* with a thesis investigating the genetic basis of musculoskeletal deformities. While earning a joint medical degree from Harvard Medical School and the Massachusetts Institute of Technology, Dr. Yeon continued his human genetics research. Enrolling in a joint program in medicine and law, Dr. Yeon earned a Doctor of Jurisprudence from Harvard Law School.

Dr. Yeon completed his Orthopedic training at the Harvard Combined Orthopedic Residency, where he was Orthopedic Chief Resident at Brigham and Women’s Hospital in Boston, MA. He completed his subspecialty training in Spine and Scoliosis Surgery at the Hospital for Special Surgery in New York City. In over a decade of clinical practice, Dr. Yeon has performed well over 2000 spinal surgeries. Dr. Yeon is also part of SMG’s Comprehensive Spine Center.

Dr. Andrew Beharrie is a fellowship-trained, board certified orthopedic surgeon who specializes in sports-related injuries of the knee, shoulder and elbow. He completed a residency in Orthopedic Surgery at The Hospital of the University of Pennsylvania and followed with a fellowship in Sports Medicine at

Lenox Hill Hospital in New York City. During his fellowship, Dr. Beharrie served as one of the assistant team physicians for the New York Jets.

Dr. Chris Inzerillo is a fellowship-trained orthopedic surgeon who specializes in sports-related injuries of the knee, shoulder and elbow. He completed his residency in Orthopedic Surgery at The Hospital of the University of Pennsylvania in Philadelphia, PA and followed with a fellowship in Sports Medicine at NYU Hospital for Joint Diseases in New York.
